"The Environmental Protection Agency, Government of Khyber Pakhtunkhwa, has accorded the approval for setup of Calcium Carbide (an import substitute) manufacturing plant by the Company (Ghani Chemical Industries Limited), at Hattar Economic Zone, District Haripur.
